

Privacy Policy

Introduction

The Chinese Bible Church of San Diego (CBCSD) is a 501(c)(3) non-profit religious organization. CBCSD is committed to protecting your privacy. This Privacy Policy explains how we collect, use, and share information about you when you visit or interact with our services and is appropriate to this website and others located at the cbcSD.com affiliated domains (“Sites”) produced and maintained by CBCSD (collectively “CBCSD” or “we”, “us”, or “our”).

Please be advised that the practices described in this Privacy Policy apply only to information gathered through the Sites. This Privacy Policy does not necessarily reflect our practices with respect to information collected through off-line means.

Information We Collect

We may collect the following types of information:

- **Personal Information:** Name, email address, phone number, or other contact details you provide when submitting an online form (e.g., prayer request, event registration, donations).
- **Financial Information:** If you make a donation or payment through our website, you may be asked to provide your payment details. These transactions are processed by third-party payment processors and the payment details are not kept by CBCSD.
- **Non-Personal Information:** Information such as your browser type, device type, IP address, and browsing habits through cookies and similar technologies.

How We Use Your Information

We use the information collected to:

- Respond to your inquiries or requests.
- Process donations, tithes, or payments for events.
- Provide updates on events, services, and other church-related activities.
- Improve our website and services through data analysis.
- **Emergency Situation:** We may also use or disclose Personal Information if required to do so by law or in the good-faith belief that such action is necessary to: (a) conform to applicable legal process served on us or the Sites; (b) protect and defend our rights and property; the Sites or our users, and (c) act under emergency circumstances to protect the personal safety of us, our affiliates, agents, or the users of the Sites or the public.

Third-Party Payment Processors

We use trusted third-party payment processors to handle online donations. When you make a

donation or payment, your financial information is transmitted directly to the payment processor. We do not store or have access to your full payment details, such as credit card numbers or bank account information.

These third-party processors have their own privacy policies governing the use and storage of your information. We encourage you to review their privacy policies to understand how they handle your personal and financial data.

Tracking User Behavior

We never use or install spyware on a computer, nor do we use spyware to retrieve information from a computer. Our websites may use "cookies" (via third-party plug-ins or services such as Google Analytics, Google Maps, YouTube, WordPress, etc). Most browsers accept cookies automatically but allow a visitor to disable them. Our websites function properly with or without "cookies" enabled.

We do not track or store personal information. Our websites may employ tracking technologies such as Google Analytics to understand site traffic and visitor information in aggregate. Children's Privacy

Our Sites do not knowingly collect personal information from anyone under the age of 13 without parental consent. If you are under the age of 13, you should use the Sites under the immediate supervision of a parent or guardian and should not submit any personal information to us. Parents and Guardians, if you are aware that we have collected personal information from anyone under the age of 13 without verification of parental consent, please contact us to have the information removed.

Sharing Your Information

We do not share your personal information with third parties except in the following cases:

- With service providers, including third-party payment processors, who help us manage the website, process donations, or deliver services (e.g., event registration platforms).
- As required by law or to protect our legal rights.

We do not sell or share your information including phone numbers and SMS consent to any third-parties or affiliates under any circumstances.

Security

We are committed to safeguarding your personal information and maintaining the security of your data. To safeguard your data, we employ industry-standard physical, technical, and

administrative measures designed to prevent unauthorized access, use, or disclosure of your personal information. We do not track or store personal information on our websites.
